I. Approval of February 2019 Minute

Dana Reed motioned to approve the February minutes. Nanette Fish seconded the motion. Motion passed.

- II. Action Items
 - a. Housing
 - SB 4 (McGuire) Enabling Inclusive Workforce and Affordable Housing The committee requested clarification regarding ministerial approval. Staff would report back at the next legislative meeting with answers to the Committee's questions. Sandra Armenta motioned to watch SB 4, seconded by Dana Reed. Motion passed.
 - ii. SB 6 (Beall) Enabling Inclusive Neighborhoods

Staff reported that SB 6 would authorize the state to establish a database that would provide public access to all available state and city vacant land and properties that could be used for affordable housing. The author removed consideration of streamlining approval language to the bill. Juan Garza motioned to support SB 6, seconded by Blanca Pacheco. Motion passed.

iii. SB 50 (Wiener) More HOMES Act of 2019

Staff recommended the Committee to take a watch position, while the Association works to secure a visit by Sen. Wiener's office to Southern California. Dana Reed motioned to watch SB 50, seconded by Juan Garza. Motion passed.

 - AB 11 (Chiu) Affordable Housing and Infrastructure Financing Agency
 Discussion reflected concerns with the bill's greenhouse gas reduction goals.
 Dana Reed requested more information be provided on the bill. Dana Reed
 motioned to table the bill, seconded by Bea Dieringer.
 - ii. SB 5 (Beall) Local-State Sustainable Investment Incentive Program
 SB 5 commits \$1 billion in ERAF funds to redevelopment projects, while holding harmless school funding. Dana Reed motioned to support SB 5, seconded by Nanette Fish.
