### Meeting Proceedings

### Reports

#### **President's Report - *President Lindsey Horvath***

- President Horvath introduced new By-Laws Committee Chair Yesenia De La Rosa, a newly elected Avalon Councilmember. President Horvath provided a brief update from the Public Safety Working Group (PSWG). PSWG has hosted public safety speakers to create recommendations for the Los Angeles County Board of Supervisors, Los Angeles County District Attorney George Gascón, and Los Angeles County Sheriff Alex Villanueva. The recommendations will be formed as three letters to each governing body in addition to a meeting with CCCA leadership.

#### **Executive Director's Report - *Marcel Rodarte***

- Marcel Rodarte is exploring the feasibility of hosting an in-person event in the fall. However, all programming through Summer 2021 will be held virtually to adhere to social distancing guidelines. Los Angeles County Advocacy Day will be held in March, programming will feature Los Angeles County Board, Supervisors; invitations will be sent in the upcoming weeks.



## Legislative Committee Report

- On behalf of Chair Stacey Armato, staff provided a report on actions by the legislative committee. Staff provided an overview of the CCCA Housing Trust Proposal. Chair Armato has met with numerous legislators to request feedback on the Proposal and its viability. The objective is to introduce the bill in this session. Updates will be shared with the Executive Board as the Proposal navigates the legislative process.

## New Business

- Extension of single signature authorization on CCCA disbursements through June 30, 2021. Julian Gold motioned to approve, seconded by Jeff Wood. No abstentions, motion passed unanimously.
