- Co-Chairs Armato and Perez gave an update on the legislative committee. They discussed the committee's review of upcoming bills and November ballot initiatives.
- Co-Chairs Armato and Perez thanked Director Rodarte and CCCA staff for their diligence in rescheduling and coordinating SLOT. The new dates are March 2-4, 2022, and the Executive Board and Legislative Committee are invited to a dinner and working meeting on Tuesday, March 1, 2022.

Other Business

- For her candidacy for Los Angeles County Board Supervisor, Lindsey Horvath requested to use CCCA communications to promote a campaign event on February 3, 2022. The Executive Board members agreed to distribute event information through the CCCA PAC accounts, not official CCCA servers.
- Co-Chairs Perez discussed the dissatisfaction with the Los Angeles County Sheriff's Department's moratorium and its impact on the City of Norwalk's ability to provide public safety services to its residents. The Public Safety Committee will review this matter further and report back to the Executive Board.
