Reports

President's Report - President Mark Waronek

- President Waronek welcomed the Executive Board to the City of Downey and reminded members of the joint meeting between Executive and Legislative Committee members on Tuesday, March 1, 2022, in Sacramento.
- President Waronek reviewed upcoming events, including the Angeles Local Advocacy Day on Thursday, April 28, 2022, from 8 AM-2 PM. CCCA's Annual Municipal Seminar

- (AMS) will be hosted in Indian Wells, May 11-15, 2022. The event will feature an Los Angeles County Sheriff (LASD) Candidates Forum.
- Per President Waronek's direction, CCCA staff is contacting potential member cities for a presentation highlighting membership.
- President Waronek and Director Rodarte met with Commerce City Manager Edgar Cisneros, who expressed a desire to have the city returned to the Association.

Executive Director's Report - Marcel Rodarte

- Director Rodarte shared updates from the meeting with Commerce City Manager Edgar Cisneros, who expressed to return to the Association. Following guidance from the Membership Committee, Commerce will return to the Association on a probationary basis, except for the individuals involved in the 2019 incident. Commerce city staff will be welcome to attend upcoming events.
- Director Rodarte and the CCCA team are in the early stages of planning Los Angeles County Local Advocacy Day, including searching for sponsors.
- Director Rodarte delivered updates from the Blue-Ribbon Commission for Homelessness (BRCH), who will finalize their recommendations to the Los Angeles County Board of Supervisors on addressing homelessness.

Legislative Committee Report - Co-Chairs Jennifer Perez and Stacey Armato

- Co-Chairs Perez gave an update on the legislative committee. The committee recently reviewed several bills, including SB 379 by Senator Scott Wiener and SB 817 by Senator Richard Pan.
- Co-Chair Perez shared information regarding the fast-tracked initiative expanding supplemental COVID-19 sick leave for employers with more than 26 employees, including cities. The committee opposes unfunded mandates.

Public Safety Committee Report - Chair Brenda Olmos

- Chair Olmos shared challenges faced by the City of Norwalk, who created a ballot initiative, Measure P, that generated nearly \$1.9 million to bring in more Los Angeles County sheriff's deputies to patrol the city. However, the moratorium by the Los Angeles County Sheriff's Department (LASD) is preventing the city from fulfilling the city's public safety needs.
- CCCA staff added Whittier, Pico Rivera, and Santa Fe Springs are considering taking on prosecutive services in their jurisdictions following a lack of action from Los Angeles County District Attorney George Gascón.

Other Business

 CCCA Secretary/Treasurer Jeff Wood provided an update for the upcoming Annual Municipal Seminar (AMS) he plans to create a theme of local collaboration and shared a proposed sponsorship letter with the Executive Board.
